



## How to File a Complaint with Your Local Police Department in Virginia

### How to Read This Guide

It may be surprising to learn that filing a complaint against a Local Police Department (or Police Officer) is not a standardized process in every city/county. We have compiled the individual processes for filing complaints in every Virginia Jurisdiction. Each city/county is listed alphabetically. In all cases, we have listed the city/county name first. For instance, “City of Richmond” would be listed as “Richmond City.”

Please be aware that most of these complaint processes are internal, meaning that members of the police department may receive and investigate the complaints themselves. Not everyone is comfortable using an internal complaint process. It is up to you to weigh the costs and benefits of reporting your own experience.

Also keep in mind that Sheriff’s Offices and Police Departments are separate, distinct entities. In most—**but not all**—areas:

**Sheriff's Offices:** manage inmate transportation, oversee local and regional jails, and provide security for courts

**Police Departments:** handle criminal law enforcement matters, including responding to 911 calls and making arrests

These descriptions and roles are not accurate in every area. Please make sure you are referencing the correct agency when making your complaint.
